

**Subject :- Request for Proposal (RFP) for the Selection of System Integrator for CCTNS Project, J&K State.**

CCTNS is an ambitious scheme to modernize the Police force and aims at creating nationwide network infrastructure for State of the Art tracking of crime and criminals. It aims at creating comprehensive and integrated system for enhancing the efficiency and effective policing at all levels especially at police station level.

Bids are invited for the selection of System Integrator for the implementation of CCTNS Project for J&K Police so as to reach the office of Nodal Officer for the implementation of scheme i.e. Inspector General of Police, Crime, J&K by or before 07-01-2012.

The detailed Terms of Reference and other qualifying conditions are contained in the tendering document prepared for the purpose which is available with the office of IGP Crime and can be bought on the payment of Rs.10,000/- (Rupees Ten thousand only) through Bank Draft during working hours/ days from 17-12-2011 till 24-12-2011. Only those bids will be accepted for evaluation for which tender documents will be issued from the office of Nodal officer.

**1. Earnest Money Deposit (EMD)**

The Bidder shall furnish while submitting the bid proposal, an Earnest Money Deposit (EMD)/ Bid security amounting to Rs. 1 Crore (Rupees one crore) in the form of Bank Guarantee or in the shape of Demand Draft drawn on a Nationalized Bank in favor of Inspector General of Police, Crime Branch, J&K payable at Jammu.
